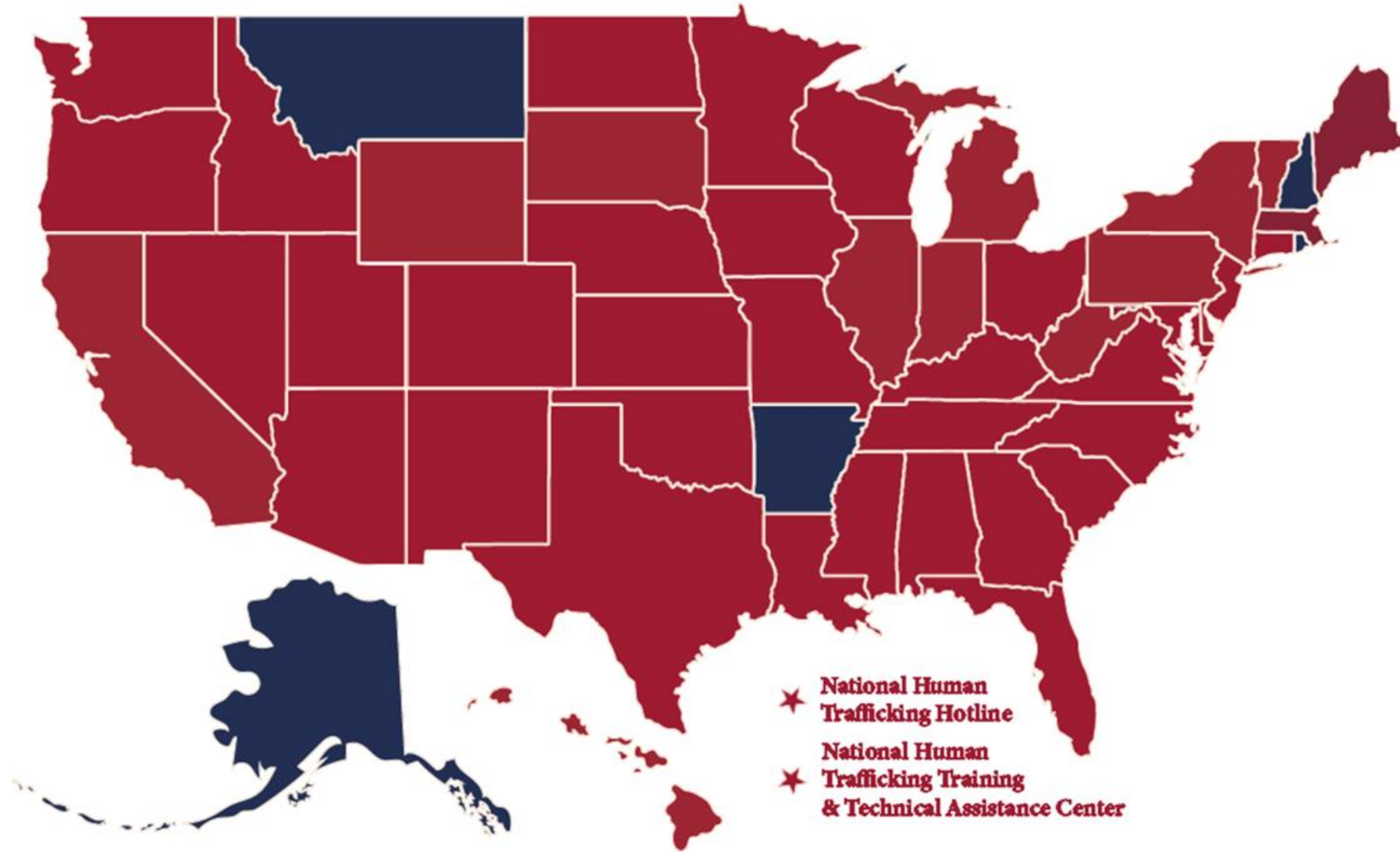


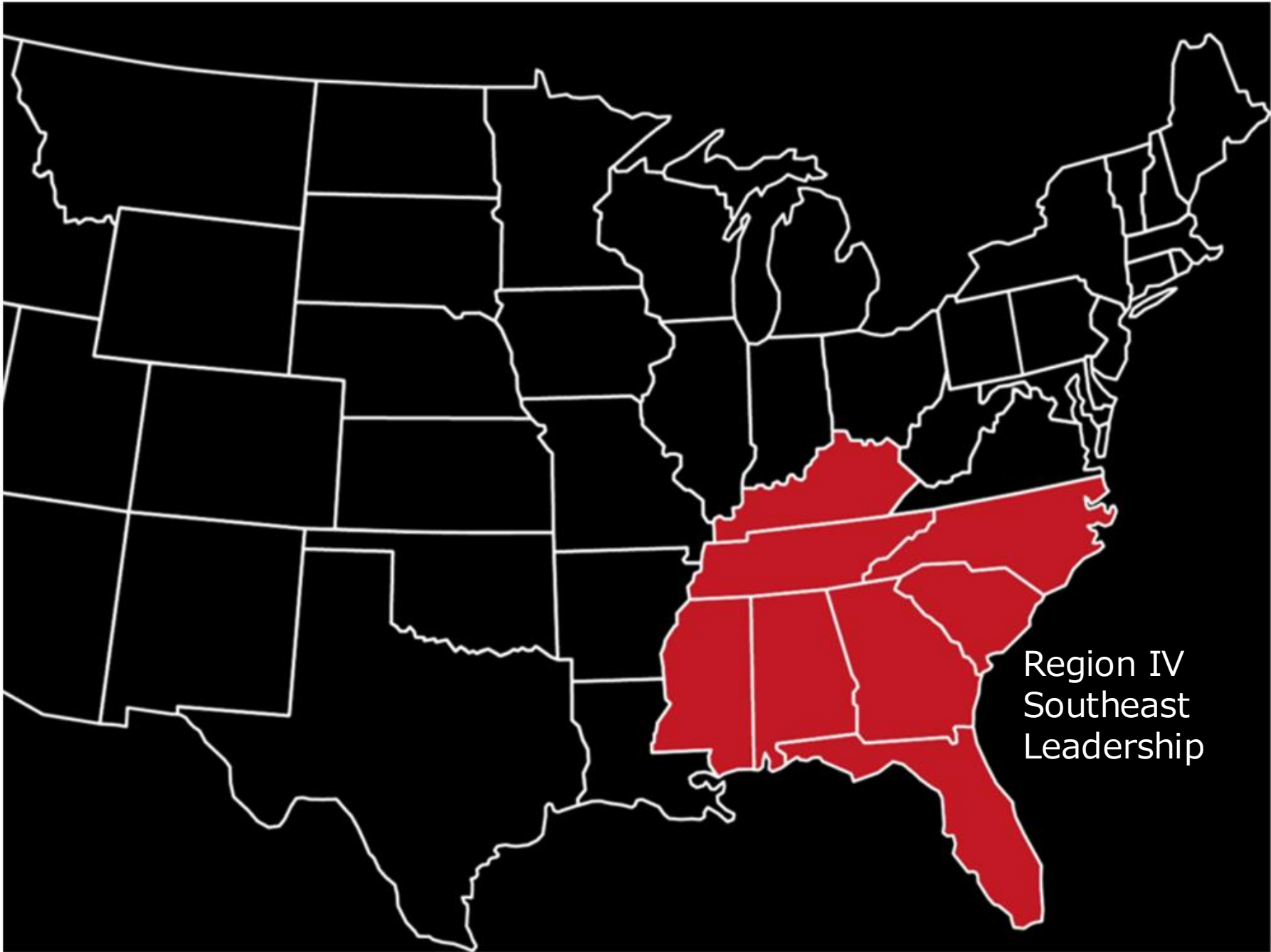

2012 Legislation

S1135

Section 16-3-2100. (A) The Attorney General shall establish an interagency task force to develop and implement a State Plan for the Prevention of Trafficking in Persons. The task force shall meet at least quarterly and should include all aspects of trafficking, including sex trafficking and labor trafficking of both United States citizens and foreign nationals, as defined in Section 16-3-2010.

Cases

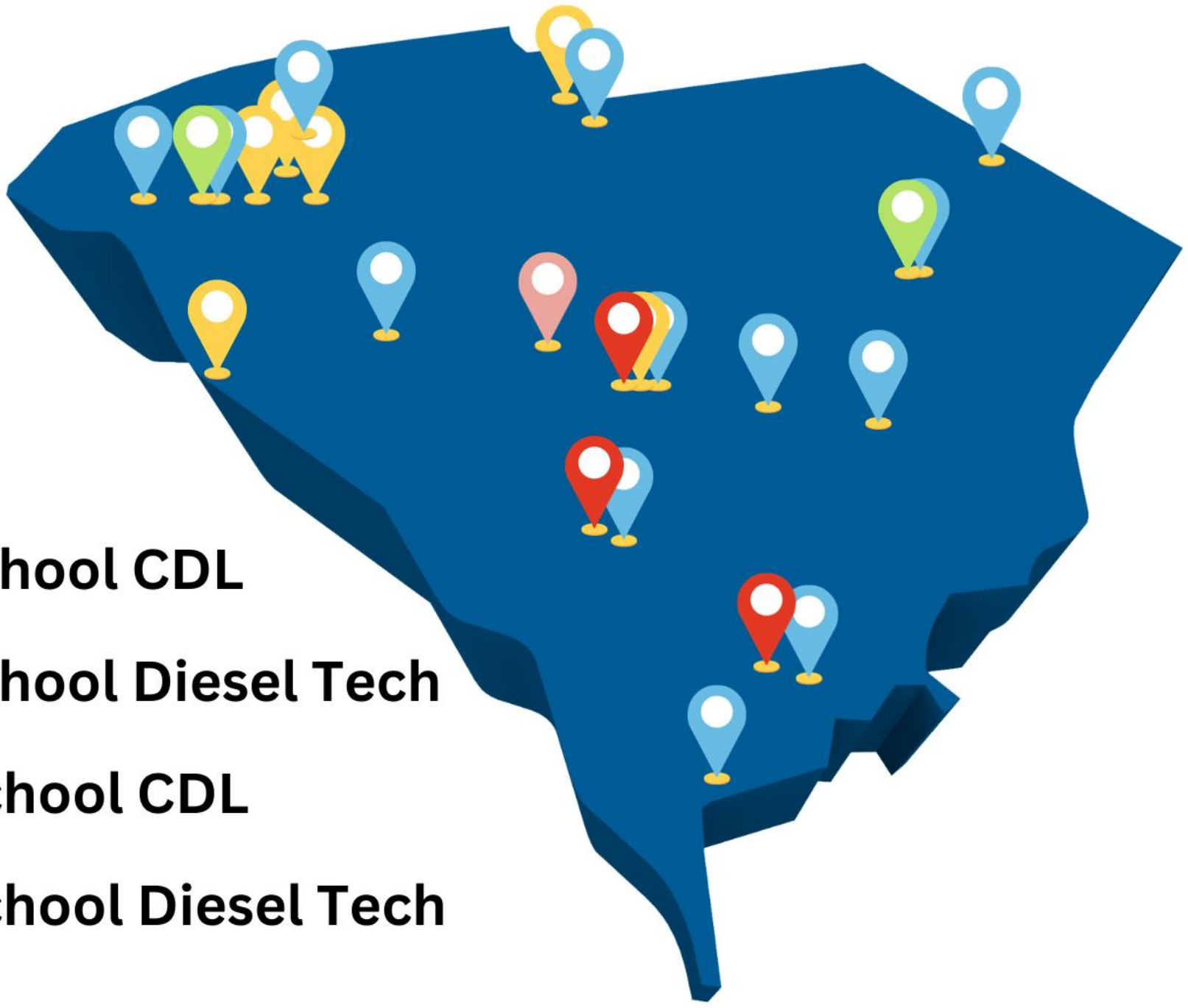
Since its inception, the Human Trafficking Hotline has identified **1,154** cases of human trafficking. **3,199** victims were identified in these cases.
